* Lost Child	* Development of social skills & expected behaviours when with other people of the community
* Sunburn, heatstroke, dehydration, extreme weather, wet weather etc	* Continue to develop relationships with key Educators whilst on the excursion
* Child Protection issues with members of the public	* Relaxation and Recreation
* Injury to children or staff from slips / trips / falls	* Development of gross motor skills and confidence in abilities
* Choking / food allergy issues when consuming food brought from home	* To develop problem solving skills when using the climbing wall and other activities
* Injury from bus accident / breakdown / braking	* To learn basic ideas of catching a bus, and how to do so, to encourage life skills
* Injury from falling from heights due to incorrect fitting of equipment, misuse of equipment or faulty equipment	* FUN!
* Children having anxiety from heights with activities	* To help children overcome anxiety from heights by completing tasks and meeting their own goals. This will further develop confidence in their abilities.
